# REPORT FROM THE PRESIDENT

JUST RECENTLY I HAD ONE OF OUR HIGHEST RANKING COMPETITORS MAKE THE STATEMENT TO ME THAT HE WAS INCREASINGLY POSITIVE ABOUT THE FUTURE OF DANCESPORT IN AUSTRALIA. HE MAY NOT KNOW IT BUT THIS CASUAL COMMENT MADE ALL THE HARD WORK OF THE LAST YEAR WORTHWHILE.

In December 2013 I advised you that 'my plan for DanceSport Australia was to double the membership and to develop a positive culture that we can all enjoy being a part of.' I would now like to report to you that in six months we have increased membership by one third (well on the way to our goal) and, if even one member feels more positive about the future, then we are also on the way to achieving the second goal.

These aims are not achievable alone and as I read through the reports here in this edition of 'Focus' I realise that the teams I work with both at National and State level share my vision. If you would like to join a DanceSport Australia team, I encourage you to get involved with your state branch - stand for election in October - nominate by contacting the Executive Officer in your state and / or offer your services as a volunteer.

I am proud to say that the current DSA National Council is strongly committed to transparent and accountable management and encourages member input. All DSA policies are available on the DSA website and a 'forum' is available on the DSA Facebook page. Contact details for all DSA directors are also on the website. Make contact – your feedback is important to us.

During 2014 I have participated in open meetings in six states to discuss new policies and to debate issues that are relevant to good management and future growth. In

launching the 'Recreational Division' the individual concerns relating to state operations were considered and changes made to improve the policy. That program is under review until the end of the year however by July 2014 the increase in membership surpassed 900 - a very encouraging result and a tribute to the Registered Teaching Facilities (RTFs) who have embraced this project in their businesses and the competition organisers who have provided for it in their programming.

The launch of the DanceSport Australia National Championship in the Gold Coast at Easter was a very special milestone for DSA - an all Australian event for Australian competitors assessed by Australian adjudicators. Some of our elite couples living overseas returned home to participate along with leading couples resident here in Australia. The event was magnificently presented by the Queensland Branch of DSA and I am extremely grateful to all involved - competitors, organisers, volunteers and supporters. The Victorian State Branch has taken up the baton for 2015 and the South Australian State Branch for 2016. This annual event is not to be missed.

DanceSport Australia's Commissions are currently developing projects and initiatives that will contribute to increased support for industry investors and the continued development of user friendly competitions.

#### The Next Step of 'Project 5000' includes

· DSA Accreditation Policy revision

- for launch in 2015. It is aimed at recognising the entry level skills of coaches and adjudicators and facilitating further development and recognition.
- DSA Team Australia this initiative being developed by the Australian Affairs Commission and the International Affairs Commission will provide additional assistance to Australian elite dancers preparing for international competition.
- Two very exciting television series.
   The concepts are confidential until all agreements have been signed but I can inform you that both will provide great Marketing opportunities for DanceSport.
- The Sport and Development Commission is developing transparent adjudication systems, special development competitions for Recreational Division competitors and adjudicator training programs.

I would like to personally thank the many hundreds of members who work tirelessly at state and national level to ensure that DanceSport Australia functions efficiently and provides so many services to our members. My appreciation also to the many sponsors who continue to contribute. The success of our sport is about people working together and I believe that this is something we do very well. Happy dancing everyone.

# PROJECT 5000 REPORT FROM THE SPORTS DIRECTOR

THE INTRODUCTION OF THE RECREATIONAL DIVISION AND THE RESTRUCTURE OF THE AMATEUR DIVISION MARK THE BIGGEST CHANGES IN THE HISTORY OF DANCESPORT IN AUSTRALIA.

As the proposed introduction period for these changes draws to a close it is appropriate to look back at the last six months and see how this restructure has been received.

Although we are still in the early stages of the development of the Recreational Division, as our competition year does not truly start until March, it is encouraging to see the Recreational competitor numbers around 900 which is double early predictions. Even the ratio of boys to girls and men to ladies has been encouraging. I am pleased to report that the actual ratio is 34% boys/men and 66% girls/women.

Recreational competitors do not exist in isolation; they have to be registered into the system by their teachers through the Registered Teaching Facility (RTF) system. The fact that 70 plus RTFs have already registered is proof that teachers, coaches and principals want input into the Recreational registration process.

It has been great to see Studios (RTFs) actively using the Recreational framework to enhance their individual

business models. Many RTF principals have shown me how they have developed their class structures around the three Recreational Levels which provide a direct link from classes to competitions. Working with RTFs is a vital aspect in the development of new DanceSport competitors.

I congratulate the DSA State Branches that have already run workshops on how to develop the Recreational syllabus and encourage all state branches to engage with their RTFs to build a solid base of knowledge. Consistency is the key, competitors (and parents/supporters) want structure and rules that are consistent from one competition to the next. The Recreational Division is proving to be popular with these participants.

Competitions that include Recreational events have now commenced and 'Points' generated from those competitions have been added to the Recreational database. These points will be used to define elevations which will occur at the start of the calendar year and now with a few months of data available the 'Points Threshold'

for elevation can now be set. DSA will advise on the points required for elevating to the next Recreational Level in the near future.

Recreational competitors can also use their points to obtain 'Vouchers' -similar to other loyalty based systems around the country. The vouchers represent discounts on goods and services supplied by vendors who are registered with DSA.

Overall it has been a positive start to 2014, very busy but also very exciting to see participation numbers increase. The best part of this project has been the positive feedback and ideas that people in the industry have brought forward and I am looking ahead to the next six months.

Please Note: DSA's National Council recently approved a number of new policies and guidelines as part of "Project 5000". These are now formally available for all members to access on the DSA website, under the tabs "About DSA" and "Other Competition Rules".

#### **Attendance and Voting Rights**

Please note the following:-

- Only persons whose names are recorded in the National Register of Members (which is the Dancesport Australia Limited membership register for the purposes of the Corporations Act), are members of Dancesport Australia Limited.
- Only Members of Dancesport Australia are entitled to attend and vote at DSA meetings.
- Receipt of a competitor registration form or other joint registration/membership form by the State Branch Registrar and/or recording of a competitor's registration status in a Branch competitor register does not constitute the recording of the name of a person in the National Register of

Members.

- Notice is hereby given that the recording of the names in the National Membership Register shall cease on August 1st and shall not recommence until November 10th.
- Branch General Meetings are not General Meetings of the Company within the meaning of that term in the Corporations Act.

#### STRUCTURE OF STATE BRANCH BOARDS

The State Branch Boards to be elected at the meeting shall comprise nine (9) representatives, viz:

- · 2 Coach Representatives
- 2 Competitor Representatives
- 5 General Member representatives

#### The following conditions apply:-

All voting for Branch Directors as representatives of their registration/licence category shall be in person or by proxy. Voting rights shall be determined by entry in the national membership register and shall be subject to the following further restrictions:

- a. Only members of the Branch are eligible to vote
- b. Only licensed coaches may nominate and/or vote for coach representatives
- c. Only registered competitors may nominate and/or vote for competitor representatives
- d. All financial ordinary members and life members may nominate and/or vote for general member representatives.
- e. A financial member who is a licensed coach may nominate and

- vote in both the coach category and in the general member category.
- f. A member who is a competitor may nominate and vote in both the competitor category and the general member Category.
- g. A member who is a competitor and coach may nominate and vote in all three categories.
- h. The order of the election process will be 1st-Coaches; 2nd-Competitors; 3rd General Members.

#### Nomination for Election to State Branch Boards

Any person who is an Ordinary Member of DSA and who has voting rights as defined above may nominate for election to the State Branch Board. Nominations must be in writing (or by fax or email), can be submitted by the nominee and do not need to be seconded. Nominations are to be received by the Branch Executive Officer 28 days prior to the date of the meeting (or such shorter time as approved by the State Branch Board). Intending nominees should refer to the conditions (a) to (g) listed under "Branch Boards" (Constitution -Clause 16).

#### **Notices of Motions**

Any member wishing to submit a notice of motion for the attention of the Bi-Annual General Meeting must submit such notice to the Branch Executive Officer in writing and to be received 28 days prior to the meeting (or such shorter time as approved by the State Branch Board).

- **24.2** An event with the title 'Teacher/Student' will be assumed to be open to all categories listed in Rule 24.3.
- **24.3** Organisers may also offer 'Teacher and Student' events in the following categories
- a) Pro/Am Professional Competitor & Amateur Division Competitor
- b) Pro/Rec Professional Competitor & Recreational Division Competitor
- c) ProC/Am Professional Coach & Amateur Division Competitor
- d) ProC/Rec Professional Coach& Recreational Division Competitor
- e) AmC/Am Amateur Coach & Amateur Division Competitor
- f) AmC/Rec Amateur Coach & Recreational Division Competitor
- **31.2** The Chairman of Adjudicators (or if a Chairman of Adjudicators is not appointed, the Competition Organiser) is notified of a breach in DSA Rules when;
- a Chairman as appointed under Rule 22, has directly observed a breach of DSA rules,
- an Adjudicator observing a breach of DSA rules, marks "N" against the competitor(s) number on his/her judging card (or electronically) or informs the Chairman of Adjudicators directly
- an Invigilator, as appointed under Rule 22, has observed the breach and informed the Chairman.

The DSA Sports Director is appointed by DSA National Council to liaise between DSA, its officials, members and event organisers to develop and supervise the implementation of DSA Rules and Policies as they apply to events and sport development.
