CHAIRMAN'S REPORT 2021

As I sit down to write my report for 2021, I am fully aware that dance studios have been closed for over 280 days since the beginning of the pandemic. I am finding it very difficult to put into words the events of the last 18 months with many people being affected emotionally, mentally and financially. This is not only in the dance industry but also throughout society in general, affecting all facets of their lives. DanceSport Victoria had some very exciting and interesting projects and initiatives planned for 2021 but unfortunately due to the COVID-19 situation we were unable to present them all.

However, we were able to present a brilliant Kickstart Competition and Lecture day. A huge thank you to all the dancers, teachers, RTFs, sponsors and board members that supported these events. Without your amazing support, events like these are not possible. Thanks must go to Max and Jean Baker for donating their scrutineering equipment and time. Meagen Alderton (Marketing Chair) and Jason Beaman (Sports Development Chair), thank you for your endless hours of hard work on Kickstart. Their commitment to promoting and growing DanceSport in Victoria is commendable. The board is already making plans for the 2022 Kickstart.

Meagen Alderton (Marketing Chair) has done a fantastic job this year in keeping our members informed and engaged with what is happening in DSV. One such project was "Ask DSV", this was a live feed interview on Facebook. It was watched by many and viewed hundreds of times from not only DSV members but also people all over Australia and the world. There will be more of these interviews in the coming months.

DanceSport Victoria has received very exciting news through Dancesport Australia that the IOC has approached the WDSF to create a Para dance division, with the view of including it as a sport for the 2028 Los Angeles Paralympics. It will additionally be an option for the 2032 Brisbane Paralympics. With Breaking being included as a sport at the 2024 Paris Olympics, the WDSF has now been made a full member of the Summer Olympics. This will open up many opportunities for DSA and the Para dancers.

In late 2020 DanceSport Australia became a recognised member of the Special Olympics. This is a very exciting opportunity for DanceSport Australia and it's members. Special Olympics are a year-round multi-sports program for people with an intellectual disability- of all capabilities. All DanceSport Australia RTF's have been offered the opportunity to become an affiliate of Special Olympics. We will be encouraging more Victorian RTF's to become members in the coming year.

It has been pleasing to hear that some RTF's have been teaching ParaDance this year. We do have some exciting things planned but they are still in their infancy and once studios are back open, we hope to continue with them.

Our Seniors Inclusion program is still very much at the forefront of DanceSport Victoria's projects but again; with COVID restrictions and lockdowns we were unable to deliver our plans this year. We endeavour to continue this once we are able.

DanceSport Victoria Competition Grants Commission has set up a "DSV Competition Relief Fund". This is to assist competition organisers who have had to cancel their event due to COVID restrictions and have incurred a financial loss because of cancellation. There is a criteria and should any further details be required please don't hesitate to contact DSV.

DSV has secured funding and grants this year. Thanks to Max and Martyn for their help in securing this. The Elite Athletes Grant called "Athletes Pathway Travel Grants", Together More Active funding and the Sporting Club Grant. Further details about the funding and grants can be found in the Executive Officer's report.

The 2021 ADS Bendigo Classic is, at this stage, planned to run in collaboration between the ADS (Vic Branch), Greater Bendigo City Council and DanceSport Victoria. This event is a must for any dancer on the DanceSport Calendar.

In 2018 Dancesport Victoria undertook a detailed Health Check of the DanceSport Victoria Board, under the Vicsport Good Governance Program. Vicsport are the peak body for sports and active recreation in Victoria and have major partnerships with the Victorian Government and VicHealth. This health check is reviewed regularly and can be found in your documents.

Many of us that have been involved in DanceSport for a long period of time will acknowledge that a decrease in numbers is not a new problem, and certainly not one isolated to Victoria. It is, however, an area that we wish to overcome and will work closely with Dancesport Australia, particularly as we navigate out of COVID-19, and continue to help grow DanceSport in Victoria. The focus will be on the grass roots and along with DSA we are looking at creating a School program. At the same time, we will be creating a Team Victoria. This is to acknowledge and help support the higher-level dancer. Further details of this can be found in the Sports Development and Marketing and Communications reports.

We have to acknowledge the support of Vicsport in promptly providing additional information to DanceSport Victoria and in turn the RTF's regarding the restrictions on our Industry due to COVID-19. Thanks must also go to Max Baker for attending these weekly meetings.

I must also acknowledge DanceSport Australia for the regular Zoom meetings they have held to connect and share information and ideas throughout 2021. The support and guidance they have given to DanceSport Victoria throughout the year is appreciated.

I would like to thank all of the Dancesport Victoria Board members for their contributions, both professionally and personally. 2021 is not the year that DanceSport Victoria had envisioned but we can only look forward to the future and hope for a bigger and better year in 2022. Looking forward to seeing you all back on the dance floor.

EXECUTIVE OFFICER REPORT – 2021

2020 was a rotten year for the dance world, especially here in Victoria – we were looking forward to a better 2021 – but COVID-19 had other ideas for us!

As my third year as Executive Officer for DanceSport Victoria comes to an end I have been very thankful for the support of the DSV Committee and especially the Chairperson (Ms Anna Longmore) our Government Liaison Officer (Mr Martyn Kibel) and the DSA CEO (Mr Dallas Williams) for their guidance throughout this incredibly difficult year for the dance industry.

My report will concentrate on some of the operational aspects of the DSV year, whilst leaving specific matters to the reports from the Marketing and Communications and Sports Development Committees.

<u>Committee Structure</u> – following the 2020 AGM and election, the following members were elected to the DSV Committee: Anna Longmore, Shane Hocking, Max Baker, Jason Beaman, Meagen Alderton, Adam Blakey, Geoff Vine, Monica Fincham and Katusha Volgina. Martyn Kibel has continued to provide support to the committee as Government Liaison Officer. We would like to thank the outgoing committee members (Loraine Fabb, Anthony Pepers and Erin Aspinall) for their contribution to DanceSport Victoria. Those candidates who did not make the committee this year were invited to join sub-committees to utilise their expertise in specific projects.

Government Funding — we have been very successful in obtaining government funding over the past twelve months. Over our normal funding through the Together More Active program, we have received funding for our nominated project - ParaDance and Seniors Inclusion. Unfortunately, due to COVID-19, we have been unable to make progress on either part of this project, but we continue to be hopeful. We applied for, and were successful in obtaining, funding under the Athlete Pathway Grants Program 2020/21. This funding was to be used to support our Elite Athletes attending interstate National Championships based on results of the ADS Victorian and ADS Southern Cross Championships. As we know, the Southern Cross event did not run, and the two interstate events Tasmania and East Coast Championships were also cancelled. This funding will be held over and used in the first half of 2022. We also received funding to assist with the purchase of a Defibrillator to be used at Victorian competitions registered with DSA.

ADS / DSV Bendigo DanceSport Classic – this event has been very successful thanks to the support of the ADS Victorian Branch, the Bendigo Stadium and the City of Greater Bendigo (CoGB). The event did not run in 2020 but is planned for October this year subject to COVID-19 restrictions. The event receives significant funding from the CoGB to encourage competitors to visit, stay and eat in Bendigo. To attract greater support of the event, this year we have invited Siggi and Anna (Sigurdur Sigurdsson & Annalisa Zoanetti) from SA to present a floorshow, run a workshop and offer private lessons whilst in Bendigo. This will be subject to COVID restrictions obviously.

COVID-19 Communications — DanceSport Victoria has been extremely active in maintaining communications with RTFs over the past twelve months to ensure they have received the most up to date information as it is released by the Victorian Government. The role of DSV has been to ensure RTFs have the most up-to-date information on the ever-changing rules and regulations to make business decisions specific to their operations. We join the Vicsport fortnightly (sometimes weekly) Zoom meetings with all other Victorian sporting organisations and government representatives (regularly up to 120 participants) to gather the most relevant and accurate information which we then pass onto RTFs. As Restricted Activity Directions (RADs) and other government releases have been received, we have been passing these on to RTFs usually within 2 hours. We have been instrumental in getting certain issues clarified again to allow RTFs to make informed business decisions especially in relation to exemptions and density queries.

<u>DSV Committee Meetings</u> – The DSV committee meets monthly, and, prior to COVID-19, these meetings were held in the Vicsport Board Room. The committee has maintained the schedule during COVID-19 and meetings have been held via Zoom. We hope to return to face-to-face meetings once access to the Vicsport Board Room is again possible.

2021 has been a very frustrating year for the dance industry with COVID-19 restrictions in Victoria tougher than the rest of Australia. We hold hope that our situation will improve and look forward to a strong recovery in 2022.

2020/21 has been an extremely challenging time for the whole of DanceSport in Australia but there is no denying Victoria has been hit the hardest. With studios closed for the best part of 300 days and only 3 competitions being able to run in almost 2 years, it has been very difficult time for our dancers, studio owners and dance enthusiasts.

KickStart 2021 was a great event for the Victorian dance community, providing educational opportunities as well as a re-entry into the competition season after the year that was 2020. Through the planning and implementing stages of the event, DSV were in communications with our member database to find out how they would like the event to look. We had amazing response to surveys that were sent out both prior to and after the event which has become priceless information when moving forward to plan KickStart 2022. The overall response from follow up communications with people who attended the event was that it was a huge success and attendees are looking to KickStart 2022.

Over the past 12 months the Marketing and Communications Team has had a focus on improving its communication with all of our members. #ASKDSV was another event that was run to allow members to interact with our committee and learn more about who we are and what we do. Anna Longmore was interviewed Live on Facebook by Matt McMahon (one of our Marketing Committee Members) and asked all things DSV. Members were able to post questions live online or send us emails prior to the event. With over 60 live viewers and since then a further 2,200 views (including international interaction) the event was well received. We look forward to bringing more of these events in 2022 when restrictions allow.

Moving forward into 2022, and working closely with the Sports Development Team, the Marketing and Communications Team are looking to continue to improve our communication with our members but also to develop strategies to promote our sport to the greater community. We are currently in the process of creating opportunities for DanceSport to be more in the public eye of the Victorian community and ensuring we don't miss any opportunity to encourage more people to engage in our sport

DSV established a Sports Development Committee in 2015, specifically to focus on growth and development opportunities of DanceSport here in Victoria.

Future plans for the rest of the year (all going well) and in to 2022 consist of:


FREE Pre-Australian Practice Session open to all Victorian DanceSport competitors




